gekuier, fyn verstellings aan vliegtuie gemaak en lekker stories en wenke uitgeuil. Die wind het wel teen laasmiddag genoeg bedaar, en twee brave vlieëniers kon 'n draai vlieg voor die son sak. Die vliegtuie en hul vlieëniers is almal weer veilig tuis en in een stuk, met geen groot of ernstige ongelukke op die aanloopbaan nie.

'n MAN het vir sy lewe gevul toe hy agmaur die oggend op 18 Junie by Wessels en Kie Grafsteenwerke in Rademeyerstraat, Oudtshoorn, in-

geharloop het met twee booswigte op sy hakke. Die man, wat anoniem wil bly as gevolg van dreigemente vanaaf sy aanvallers dat hulle hom gaan kry en sy keel afsny, is enkele minute voor die voorval deur sy werkgewer betaal. Die aanvallers het gesien toe hy die geld ontvang, en die volgende oomblik het hulle hom aangeval. Die man het by die grafsteenwerke ingehardloop met die hoop op beskerming teen die aanvallers. Daar het 'n geveg uitgebreek en die aanvallers het die man geslaan en geskop, ter-

wyl hulle vir hom skree om die geld aan hulle te gee. Duné Kuyler van Wessels en Kie, was op daardie stadium saam met 'n klient in die kantoor gewees toe sy die bokaal in die werkswinkel hoor. Sy het dadelik die polisie gebel. "Gelukkig is die manne wat by ons werk nie bang vir sulke moeilikheidsmakers nie, en hulle het die twee manne vinnig verjaag. Die polisie het 'n paar minute daarna opgedaag en die man veilig by sy huis gaan aflaa", het sy aan *Die Hoorn* vertel. Sy het verder gesê dat dit vir haar hartverskeurend is dat mense so lewens so in gevaar kan wees, en dit oor R70 wat die man op 'n eerlike en hardwerkende manier verdien het.
